The length of time in treatment for patients in an integrated setting was compared to the State of New Jersey's mandatory examination protocols and summarized in the New Jersey Alcohol and Drug Abuse Data System (ADADS) six-month report for the period of January 1, 1998 July 1, 1998. The ages ranged from 0-55 and the $n = 29,857$. The ADADS data indicates that 66% of all patients who entered a treatment program other than an integrated system were discharged in as little as 14 days. Conversely, the mean of time for all patients admitted into the study was 56.41 days, and the standard deviation was 34.94 days. The ages of the patients in the integrated setting were the same and the $n = 256$. Medical services dominated behavioral treatment by a ratio of 2:1. The analyses of these differences clearly suggest that integrated treatment is the best form of comprehensive care for these patients.
