📖 **THE LIGHTHOUSE FUNCTION OF SOCIAL LAW** YVES JORENS, 2023-07-30

THIS IS THE CONFERENCE BOOK FOR THE XIV EUROPEAN REGIONAL CONGRESS OF THE INTERNATIONAL SOCIETY FOR LABOUR AND SOCIAL SECURITY LAW, DEDICATED TO THE INTERACTIONS BETWEEN SOCIAL LAW AND OTHER AREAS OF LAW. IN RECENT YEARS, LABOUR LAW AND SOCIAL SECURITY LAW HAVE BEEN SUBJECT TO VARIOUS REFORMS AND DEVELOPMENTS. SOCIAL LAW IS HOWEVER NOT AN ISOLATED DOMAIN BUT RATHER INTERACTS WITH OTHER FIELDS, OFTEN EVEN FUNCTIONING AS A GUIDE OR GIVING DIRECTION TO THOSE LOST AT SEA. IN OTHER WORDS: SERVING AS A LIGHTHOUSE. THE KEY ASPECT ADDRESSED IN THIS BOOK IS THE EXISTENCE OF A CONNECTION BETWEEN SOCIAL LAW *SENSU STRICTO* (LABOUR LAW AND SOCIAL SECURITY LAW) AND OTHER AREAS OF LAW. PURSUING AN INTER- AND MULTIDISCIPLINARY APPROACH, IT GATHERS CONTRIBUTIONS ON TOPICAL AND CHALLENGING ISSUES IN FOUR BROAD AREAS: 1. BASIC AND FUNDAMENTAL PRINCIPLES OF EUROPEAN SOCIAL LAW 2. THE FUTURE IN THE LIGHT OF THE PAST 3. THE IMPACT OF REGIONALISATION 4. ENFORCEMENT IN SOCIAL LAW IN TURN, VARIOUS DEVELOPMENTS CAN BE IDENTIFIED IN CONNECTION WITH THESE TOPICS: THE EMERGENCE OF SOCIAL CRIMINAL LAW IS CREATING NEW OVERLAPS BETWEEN SOCIAL AND CRIMINAL LAW; THE GROWING NUMBER OF ADMINISTRATIVE LAW SANCTIONS OFFERS NEW INSIGHTS INTO AND CONNECTIONS BETWEEN SOCIAL SECURITY LAW AND ADMINISTRATIVE LAW; THE INCREASING SIMILARITY OF EMPLOYMENT IN THE PUBLIC AND PRIVATE SECTORS RAISES QUESTIONS ABOUT THE APPLICABILITY OF ADMINISTRATIVE LAW IN LABOUR LAW RELATIONS; THE RELATION BETWEEN THE ECHR AND THE ARTICLES OF THE CONSTITUTION OPENS UP NEW PERSPECTIVES ON THE CONSTITUTIONAL INTERPRETATION OF FREEDOMS AND ON THE INTERACTION BETWEEN HUMAN RIGHTS, CONSTITUTIONAL LAW AND SOCIAL LAW; AND LASTLY, THERE IS A GROWING INFLUENCE OF EU LAW AND INTERNATIONAL TREATY LAW (CONCERNING TRADE) ON SOCIAL LAW. CAN WE, BY LOOKING AT THESE DEVELOPMENTS, DRAW CERTAIN CONCLUSIONS AT A DIFFERENT AND INNOVATIVE LEVEL? THE CONTRIBUTIONS WERE SELECTED BY AN INTERNATIONAL WORKING GROUP OF DISTINGUISHED SCHOLARS FROM ACROSS EUROPE.

DESPITE DRAMATIC ADVANCES IN LED TECHNOLOGIES (E.G., GROWTH, DOPING AND PROCESSING TECHNOLOGIES), HOWEVER, THERE REMAIN CRITICAL ISSUES FOR FURTHER IMPROVEMENTS YET TO BE ACHIEVED FOR THE REALIZATION OF SOLID-STATE LIGHTING. CHIP PROCESSING AND PACKAGING TECHNOLOGIES ARE KEY ISSUES. THIS BOOK PRESENTS A COMPREHENSIVE REVIEW OF CONTEMPORARY LED ISSUES. ❏ **STEERING AGAINST SUPERBUGS** OLIVIER RUBIN, ERIK BAEKKESKOV, 2023-05-19 MANY PEOPLE CORRECTLY UNDERSTAND THAT SUPERBUGS CAN THREATEN HEALTH. SUPERBUGS ARE MICROBIAL ORGANISMS, INCLUDING BACTERIA, VIRUSES, PARASITES, OR FUNGI, THAT RESIST ONE OR MORE

ANTIBIOTIC OR OTHER ANTIMICROBIAL TREATMENTS. WHAT MAY BE LESS WIDELY UNDERSTOOD IS THAT THE THREAT IS GLOBAL, GROWING, AND ENCOMPASSES HUMAN SYSTEMS SURROUNDING HEALTHCARE, AGRICULTURE, AND THE ENVIRONMENT. IN 2019, 1.3 MILLION PEOPLE AROUND THE WORLD ARE ESTIMATED TO HAVE DIED FROM RESISTANT MICROBES (MURRAY ET AL., 2022). THIS IS SIMILAR TO HOW MANY SUCCUMB ANNUALLY TO HIV/AIDS AND MALARIA COMBINED (LAXMINARAYAN, 2022). THE RECENT CORONAVIRUS PANDEMIC MAY HAVE FURTHER EXACERBATED THE GLOBAL HEALTH CHALLENGE POSED BY SUPERBUGS (RIZVI & AHAMMAD, 2022; ADEBISI ET AL., 2021; RODRÍGUEZ-BARRO ET AL., 2021). BY 2050, WORST-CASE PROJECTIONS INCLUDE ANNUAL SUPERBUG FATALITIES OF TEN MILLION PEOPLE (O'NEIL, 2016). SOME EXPERTS HAVE STARTED TO REFER TO THE INCREASE AND SPREAD OF SUPERBUGS AS THE OVERLOOKED OR SILENT PANDEMIC (LAXMINARAYAN, 2022; UN, 2020; MAHONEY ET AL., 2021). OTHER EXPERTS WARN THAT WE MIGHT BE HEADING TOWARDS A 'POST-ANTIBIOTIC' ERA WHERE MINOR INFECTIONS BECOME INCREASINGLY SEVERE OR EVEN IMPOSSIBLE TO TREAT (REARDON, 2014; KWON & POWDERLY, 2021). ANNUAL ECONOMIC LOSSES RELATED TO SUPERBUGS ARE ALREADY ESTIMATED IN THE TENS OF BILLION U.S. DOLLARS (HALL, McDONELL & O'NEIL, 2018). AS A RESPONSE TO THESE GLOBAL CHALLENGES, THIS BOOK ANALYSES AND DISCUSSES WAYS TO REDUCE BARRIERS TO AND CREATE OPPORTUNITIES FOR GLOBAL GOVERNANCE OF ANTIMICROBIAL RESISTANCE. OR MORE BRIEFLY, STEERING AGAINST SUPERBUGS--

THIS MONOGRAPH INVESTIGATES CURRENT ISSUES IN LABOUR LAW ENFORCEMENT FROM A SOCIO-LEGAL PERSPECTIVE. IT ANALYSES HOW LOCAL ITALIAN ENFORCEMENT ACTORS PROMOTE THE PROTECTION OF WORKERS IN PRATO – A CITY THAT IN RECENT DECADES HAS SEEN A SIGNIFICANT INFLUX OF CHINESE MIGRANTS WHO RUN SMALL WORKSHOPS AS PART OF THE LOCAL CLOTHING INDUSTRY. MANY OF THE CHINESE FIRMS IN PRATO FAIL TO LIVE UP TO CORE LABOUR STANDARDS, SUCH AS MAXIMUM WORKING HOURS, HEALTH AND SAFETY AT WORK AND PAYMENT OF SOCIAL SECURITY CONTRIBUTIONS. THE BOOK ANALYSES THE STRATEGIES AND PRACTICES EMPLOYED BY THREE LOCAL ENFORCEMENT ACTORS (LABOUR INSPECTORS, LABOUR UNIONISTS AND A NEW TYPE OF LABOUR LAW CONSULTANT) IN THEIR EFFORTS TO ASSIST CHINESE FIRMS IN IMPROVING THEIR LEVEL OF LABOUR LAW COMPLIANCE. COMBINING DOCUMENTARY, INTERVIEW AND OBSERVATIONAL DATA, THE BOOK APPLIES THEORIES OF LEGAL CULTURE AND LEGAL DEVELOPMENT TO ADDRESS THE INTERACTION BETWEEN LAW AND SOCIETY. IT FOCUSES ON THE OPERATIONAL ASPECTS OF LAW BY ASKING THREE INTERRELATED RESEARCH QUESTIONS: HOW DO LOCAL ENFORCEMENT ACTORS PROMOTE THE PROTECTION OF WORKERS IN CHINESE FIRMS IN PRATO? WHICH TOOLS ARE EMPLOYED, AND WHICH

RATIONALITIES DRIVE THE INITIATIVES? THE BOOK THEREBY SHEDS LIGHT UPON PROCESSES OF LEGAL CULTURAL ADAPTATION, INFORMING ONGOING INTERNATIONAL AND NATIONAL DEBATES ABOUT WHAT CAN ACTUALLY BE DONE TO COMBAT CONTEMPORARY GAPS IN THE PROTECTION OF WORKERS.

IT SEEKS TO CONFRONT THREE FUNDAMENTAL QUESTIONS: HAS LEGITIMACY SIGNIFICANTLY CHANGED? WHO CREATES NORMS AND WITH WHICH CONSEQUENCES FOR LEGAL PROCEDURES AND NORMS? THE BOOK CONSIDERS THE QUESTION OF LEGITIMACY FROM A BROAD RANGE OF LEGAL PERSPECTIVES, INCLUDING ENVIRONMENTAL LAW, HUMAN RIGHTS LAW AND COMMERCIAL LAW. IT MAPS OUT THE CONTOURS OF LEGITIMACY TODAY WITH AN EMPHASIS ON THE REACTIONS OF CENTRAL ACTORS LIKE STATES AND COURTS TO TRANSNATIONAL TENDENCIES. THE BOOK THEREBY PROVIDES A CONCEPTUALLY POWERFUL STRUCTURE WITHIN WHICH TO FURTHER DEBATE THE COMPLEXITY OF TRANSNATIONAL TENDENCIES IN LAW AND PROPOSES INNOVATIVE APPROACHES TO PROBLEM SOLVING WHILE DESIGNING PATHWAYS FOR FURTHER REFLECTION ON THE DEVELOPMENT OF LAW IN A TRANSNATIONAL CONTEXT.
