The Inquiry makes some 200 recommendations, designed to advance the central notion of a patient-centred healthcare service committed to continuous improvement. The need for a change in the culture of the NHS is of prime concern. The recommendations cover: needs of very sick children; safety; competence of healthcare professionals; organisation within hospitals; standards of care; openness; monitoring of clinicians. The Inquiry recommends the development of national standards for all aspects of the care and treatment of children with congenital heart disease (CHD).
