As I did accept my boundaries, I also realized I am no different than anybody else because we all have boundaries in our lives, just whether we want to accept them or not, and my disabilities are visible but others may not be visible. But like the child in the mens dressing room where I was getting dressed looked at me and asked me what happened and I said this is aware it came and its just because, and then he says it looks strange and then he said it looks like a chicken wing, I broke out laughing and just had to leave before his father started to apologize for his sons curiosity and honesty. And if I didnt have the sense of humor with this disability, I would go batty and there are a lot more stories that I could tell like this.
